### Payment

Participation in Trinity of Chemung County services is voluntary. Most insurances are accepted and a sliding fee scale is available. No person is denied services based on inability to pay.

### Operating License

Trinity of Chemung County is Licensed by New York State Office of Alcoholism and Substance Abuse Services (OASAS). Our staff includes Credentialed Alcohol and Substance Abuse Counselors.
